#### Introduction

Military customs and traditions are an essential

part of the Navy.

Ceremonies commemorate feats of bravery and significant events, such as:

- Graduations
- Chiefs' initiations
- "Crossing the line"

These form the basis upon which our Core Values were founded.

# Introduction (Cont.)

In the past, some of these traditions and rites of passage included hazing.

#### Hazing is:

- Degrading
- Embarrassing
- Dangerous—even deadly

Some Sailors claim that hazing:

- Is part of the Navy tradition
- Instills esprit de corps and unit cohesion
- Provides a sense of accomplishment

### Introduction (Cont.)

- Provides sense of accomplishment

The *truth* is that hazing actually has the *opposite* effect.

Hazing is unprofessional, contrary to our Navy Core Values, and illegal.

### **Importance**

Hazing is contrary to our Core Values because it degrades and diminishes the ability of victims to function within their units by destroying their confidence and trust in their shipmates.



This is destructive to unit cohesion and combat readiness.

### Importance (Cont.)

Hazing is NOT part of our "time-honored traditions," and it has no place in the modern Navy.

It is important to know what hazing is and the Navy's policy on hazing so you can help ensure that every Sailor has the opportunity to be a productive and contributing member to combat readiness.

#### **Definition**

Hazing is any conduct whereby a servicemember (regardless of service or rank) without proper authority causes another servicemember (regardless of service or rank) to suffer or be exposed to any activity that is cruel, abusive, humiliating, oppressive, demeaning, or harmful.

### **Examples**

#### Hazing includes:


- Playing abusive or ridiculous tricks
- Forcing or requiring the consumption of any substance
- Requiring excessive physical exercise beyond what is required to meet standards
- Branding

- Greasing
- Painting
- "Pinning," "tacking on," "blood wings"
- Shaving
- Striking
- Taping
- Tattooing
- Threatening or offering violence or bodily harm to another

### Non-Examples

Hazing does NOT include command-authorized activities, actions, or operations, such as:

- Administrative corrective measures
- Athletic events
- Contests, competitions, or other similar activities
- Extra military instruction
- Physical training
- Required training to prepare for missions or operations

Reprisals against any victim or witness of hazing are also prohibited.

# Sailors' Responsibilities

#### Sailors must:

- Ensure hazing does
   NOT occur
- Refuse to engage in hazing or consent to being hazed
- Report hazing to the appropriate authorities

# Supervisors' Responsibilities

Commanders or supervisors must ensure:

- All ceremonies and initiations comply with policy
- All servicemembers participating in command-authorized activities are treated with dignity and respect during these events

You may NOT (by act, word, deed, or omission) allow or ignore hazing if you know, or reasonably should have known, that hazing may or did occur.

#### Consequences

SECNAVINST 1610.2 (series)—DON Policy on Hazing—is a *lawful general order*.

ANYONE WHO VIOLATES,
ATTEMPTS TO VIOLATE, OR



#### **Process**

The CO must be informed immediately of any allegation of hazing.

Every reported incident of hazing must be investigated to determine if the case is substantiated or unsubstantiated.



#### **Victims & Witnesses**


Anyone who has been hazed or whose command believes may have been subjected to hazing will be considered a victim or witness.



# Victims & Witnesses (Cont.)

Victims or witnesses will be:

- Advised of their rights
- Offered legal advice



- Offered medical assistance
- Offered counseling
- Advised of and given access to victim/witness advocacy services in accoradance with policy
